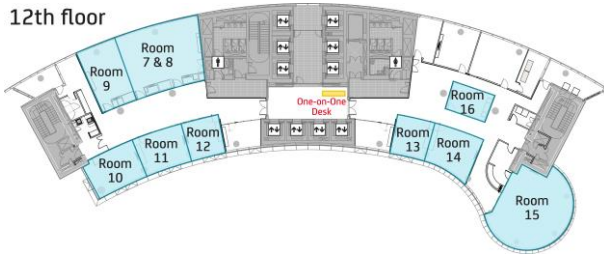

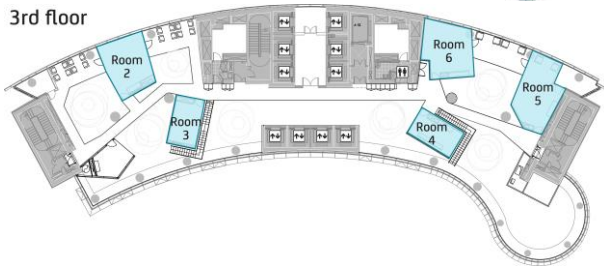
FLOORPLAN

Tower A

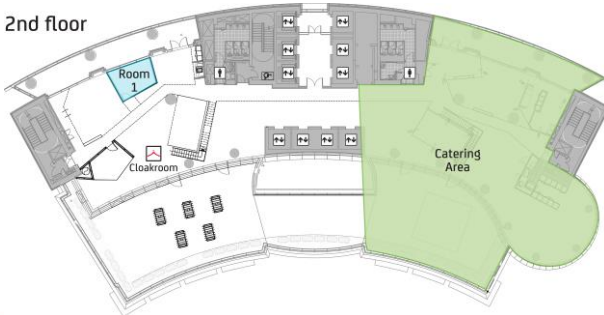
12th floor



3rd floor

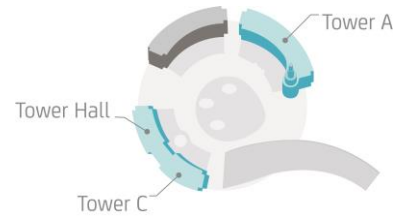
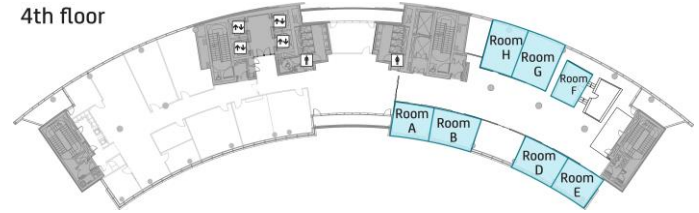


2nd floor
